#### MODE OF MEETING

In line with the Government's directive and the revised Guidance Note and Frequently Asked Questions on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia ("SC") on 7 April 2022, the 5<sup>th</sup> AGM of the Company will be conducted fully virtual through live streaming and online voting via Remote Participation and Voting ("RPV") facilities provided by Tricor Investor & Issuing House Services Sdn. Bhd.

An online meeting platform used to conduct the meeting can be recognised as the meeting venue or place as required under Section 372(2) of Companies Act 2016 provided that online platform is located in Malaysia. Pursuant to the SC's Guidance, all meeting participants including Chairman of the meeting, board members, senior management and shareholders are to participate in the meeting online.

### **REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES**

The RPV facilities are available on Tricor's **TIIH Online** website at https://tiih.online.

Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the 5<sup>th</sup> AGM using RPV facilities from Tricor.

A shareholder who has appointed a proxy(ies) or attorney or authorised representative(s) to participate at this 5<sup>th</sup> AGM via RPV must request his/her proxy(ies), attorney(s) or authorized representative(s) to register himself/herself for RPV at TIIH Online website at <u>https://tiih.online</u>.

(d)	Participate through Live Streaming	<ul> <li>Select the corporate event: "(LIVE STREAM MEETING) GAGASAN NADI CERGAS 5<sup>th</sup> AGM" to engage in the proceedings of the 5<sup>th</sup> AGM remotely.</li> <li>If you have any question for the Chairman/ Board, you may use the query box to transmit your question. The Chairman/ Board will endeavor to respond to questions submitted by remote participants during the 5<sup>th</sup> AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.</li> </ul>	
(e)	Online Remote Voting	<ul> <li>Voting session commences from 10.00 a.m. on Monday, 30 May 2022 until a time when the Chairman announces the end of the session.</li> <li>Select the corporate event: "(REMOTE VOTING) GAGASAN NADI CERGAS 5<sup>th</sup> AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>	
(f)	End of remote participation	• Upon the announcement by the Chairman on the closure of the 5 <sup>th</sup> AGM, the Live Streaming will end.	

# NOTE TO USERS OF THE RPV FACILITIES:

- 1. Should your registration for the RPV facilities be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

# ENTITLEMENT TO PARTICIPATE/GENERAL MEETING RECORD OF DEPOSITORS ("ROD")

 Only members whose names appear on the Record of Depositors as at 23 May 2022 shall be eligible to participate, speak and vote at the 5<sup>th</sup> AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.

## APPOINTMENT OF PROXY/ CORPORATE REPRESENTATIVE/ ATTORNEY

- If you are not able to participate in the 5<sup>th</sup> AGM remotely, you are encouraged to appoint the Chairman of the Meeting as your proxy and indicate the voting instruction in the Form of Proxy.
- If you wish to participate in the 5<sup>th</sup> AGM yourself, please do not submit any Proxy Form for the AGM. You will not be allowed to participate in the AGM together with a proxy appointed by you.
