#### MODE OF MEETING

The Company's 6<sup>th</sup> AGM will be conducted on a fully virtual basis through live streaming and online meeting platform via Remote Participation and Voting ("RPV") facilities provided by Tricor Investor & Issuing House Services Sdn. Bhd.

According to the Revised Guidance Note and FAQs on the conduct of General Meeting for Listed Issuers issued by the Securities Commission Malaysia, an online meeting platform can be recognised as the meeting venue or place under Section 327(2) of Companies Act 2016 provided that the online platform is located in Malaysia and all meeting participants including Chairman of the meeting, Board members, senior management and shareholders are to participate in the meeting online.

## **REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES**

The RPV facilities are available on Tricor's **TIIH Online** website at https://tiih.online.

Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the 6<sup>th</sup> AGM using RPV facilities from Tricor.

Kindly refer to Procedures for RPV as set out below for the requirements and procedures.

(d)	Participate through Live Streaming	Select the corporate event: <b>"(LIVE STREAM MEETING) GAGASAN NADI</b> <b>CERGAS BERHAD 6TH AGM"</b> to engage in the proceedings of the AGM remotely. If you have any question for the Chairman/ Board, you may use the query box to transmit your question. The Chairman/ Board will endeavor to respond to questions submitted by remote participants during the 6 <sup>th</sup> AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.	
(e)	Online Remote Voting	<ul> <li>Voting session commences from 10.00 a.m. on Wednesday, 7 June 2023 until a time when the Chairman announces the end of the session.</li> <li>Select the corporate event: "(REMOTE VOTING) GAGASAN NADI CERGAS BERHAD 6TH AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>	
(f)	End of remote participation	• Upon the announcement by the Chairman on the closure of the 6 <sup>th</sup> AGM, the Live Streaming will end.	

# NOTE TO USERS OF THE RPV FACILITIES:

- 1. Should your registration for the RPV facilities be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

# ENTITLEMENT TO PARTICIPATE/GENERAL MEETING RECORD OF DEPOSITORS ("ROD")

Only members whose names appear on the Record of Depositors as at 30 May 2023 shall be eligible to participate, speak and vote at the 6<sup>th</sup> AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.

## APPOINTMENT OF PROXY/ CORPORATE REPRESENTATIVE/ ATTORNEY

- If you are not able to participate in the 6<sup>th</sup> AGM remotely, you are encourage to appoint the Chairman of the Meeting as you proxy and indicate the voting instruction in the Proxy Form.
- If you wish to participate in the 6<sup>th</sup> AGM yourself, please do not submit any Proxy Form for the AGM. You will not be allowed to participate in the AGM together with a proxy appointed by you.
